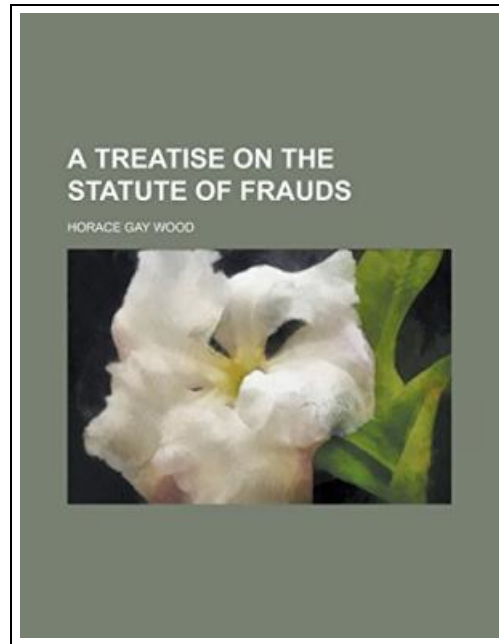

And it has been laid down, that where the agreement is to be performed upon a contingency, and it does not appear, within the agreement, that it is to be performed after a year, there a note in writing is not necessary, for the contingent and uncertain event might happen within the year; but where it appears by the whole tenor of the agreement, that it is to be performed after the year, there a note is necessary, otherwise not.
