

The following opinion, rendered upon a reconsideration of the decision of June 21, 1889, in the case of Rowland M. Jones, appealed by his widow, Julia W. (page 72, vol. 3), was designed to correct the error of law whereby said decision held that the rate of 31. 25 was still retained as first-grade rate for a disability requiring regular personal aid and attendance. I have re-examined the papers in this case for the purpose of determining whether or not there was error, as alleged, in the rating that was granted the deceased soldier in 1877, when his rate was increased from 11. 25 in 1873 to 31. 25 per month from February 14, 1877.
